Judging & Prizes

- 1. Judges will take into account the criteria as described on the Entry Requirements.
- 2. Judges' decisions are final.
- 3. Judges and the Competition Organiser will not enter into or engage, in any correspondence, discussion or debate about the outcome of the Competition or about any individual Entry.
- 4. The Competition Organiser reserves the right to declare any Entry ineligible if in its opinion, the Entrant has not complied with these terms and conditions set out in the Entry process or if the Entrant is deemed to be acting outside the spirit of the Competition.
- 5. Each Category will only proceed to the judging stage if there are three (3) or more Entries for a category. If there is less than three (3) Entries in a Category the Organiser reserves the right to not award a prize in that Category.
